

DICKINSON COUNTY FAIR GROUND RULES

1. ALL MONEY FOR CAMPING WILL BE COLLECTED BY THE CARETAKER OF THE DICKINSON COUNTY FAIR GROUNDS. FEES MUST BE PAID BEFORE SETTING UP. THE COST IS \$20/NIGHT. USE THE LOCKED DROP BOX FOR PAYMENT WHEN CARETAKER IS NOT AVAILABLE.
2. **THERE IS NO VEHICLE PARKING OF ANY KIND NEAR THE BARNs or COVERED ARENA.** VEHICLES, CAMPING UNITS, HORSE or STOCK TRAILERS MUST BE PARKED IN DESIGNATED AREAS ONLY.
3. ALL CAMPING UNITS MUST BE IN DESIGNATED CAMPING AREA. THIS WILL BE ENFORCED. THE COMBINATION UNITS OF HORSE TRAILER AND CAMPER MUST BE IN THE CAMPING AREA, IF YOU ARE CAMPING IN IT.
NO ANIMALS ARE ALLOWED IN THE CAMPING AREAS AND TRAILERS MUST BE CLEANED OUT IN THE DESIGNATED MANURE PIT BEFORE BEING MOVED INTO THE CAMP GROUNDS.
4. CLEANING OF HORSE TRAILERS ON FAIRGROUND PROPERTY IS ONLY PERMITTED IN THE DESIGNATED MANURE PIT AREA. DO NOT CLEAN OUT TRAILERS IN THE BARN, TRAILER PARKING, OR COMMON AREAS.
5. SPECTATORS MUST PARK IN THE PARKING LOT ON THE OUTSIDE OF THE FENCE.
6. UNATTENDED HORSES TIED TO TRAILERS WHO DIG HOLES, THESE HOLES MUST BE FILLED IN BY THE OWNER OR THE SPONSORING GROUP OF THE EVENT.
7. EXTENSION CORDS ARE NOT ALLOWED TO BE USED IN THE BARNs.
8. PLEASE REVIEW ALL RULES & RENTAL FEES FOR ANY UPDATES.
9. **FAILURE TO COMPLY WITH RULES & REGULATIONS:** AFTER ONE VERBAL WARNING FROM THE CARETAKER OR DICKINSON COUNTY FAIR BOARD, YOU WILL BE ESCORTED OFF THE PREMISES BY THE DICKINSON COUNTY SHERIFF'S DEPARTMENT.
